VI. Entry Requirements 申請資格

International applicants who meet the following requirements are eligible to apply:

外籍學生須符合下列資格方能申請：

A. Nationality Requirements: 國籍規定

1. Applicants must have never studied in Taiwan before as an Overseas Chinese Student at the point of application nor have accepted the assignment of the University Entrance Committee for Overseas Chinese Students in the year of application. Applicants must apply in accordance with the Ministry of Education (MOE) "[Regulations Regarding International Students Undertaking Studies in Taiwan.](#)"

具外國國籍且於申請時未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發，得依教育部《外國學生來臺就學辦法》申請入學。具外國國籍且兼具中華民國國籍者另須符合教育部 [《外國學生來臺就學辦法》](#) 相關規定。

NOTE: According to Article 2, "Nationality Act of the Republic of China", a person shall have the nationality of the ROC under any of the conditions provided by the following Subparagraphs:

- a. His/her father or mother was a national of the ROC when he/she was born.
- b. He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the ROC at the time of death.
- c. He/she was born in the territory of the ROC, and his/her parents can't be ascertained or both were stateless persons.
- d. He/she has undergone the naturalization process.

Preceding Subparagraph 1 and Subparagraph 2 shall also apply to the persons who were minors at the time of the amendment and promulgation of this Act.

四、歸化者。

前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

2. Stateless individuals are not eligible to apply for enrollment at universities in Taiwan. Please refrain from applying.

無國籍者不可於臺灣申請入學。請勿申請。

B. Academic Qualifications Requirements 學歷規定

1. To transact the assessment and recognition of foreign academic credentials, applicant's graduation institution shall meet the following requirements: recognition for academic credentials of foreign institutions of higher education listed in the MOE reference list (<http://www.fsedu.moe.gov.tw/>), or the school is recognized by the competent educational authority or by a relevant accreditation agency in the home country.

Note: Applicants with a previous degree from Mainland China are subjected to the following regulations.

- a. The university where the previous degree was obtained must be listed under MOE's "List of Recognized Higher Education Institutions in Mainland China" (Chinese version only).
- b. The period of study must fulfill the minimum requirements of Article 7 of MOE's "Regulations on Academic Qualifications from Mainland China" (Chinese version only).
- c. One must not meet any circumstances listed under Article 9 of MOE's "Regulations on Academic Qualifications from Mainland China" (Chinese version only).

2. Applicants with a Bachelor's degree or above are eligible to apply for post-Baccalaureate programs.

3. The enrollment period of one's previous degree should meet the following requirement: at least 32 months of enrollment prior to conferral of a bachelor's degree, at least 8 months of enrollment prior to conferral of a master's degree.

The financial statement must be an English document issued by a bank within the last 6 months and must reflect a cash amount of at least 4,000 USD, in order to complete the online reply. Failure to submit the required financial statement by the deadline or submitting a document that does not meet the requirements will result in the applicant voluntarily giving up their qualification. If the bank account statement is under the applicant's parent's name, please submit the bank statement and the financial supporter's signed guarantee of financial support.
